THE YEAR 2020

GLOBAL SOLIDARITY IN THE FACE OF THE PANDEMIC

It's a question of solidarity. For medico international as an aid and human rights organisation this means taking the side of people affected by oppression and war and those excluded by globalised capitalism in the struggle for an equitable world. This springs from our conviction that the same rights apply and must be respected for every individual. Our goal is to create social relationships which permit a life with dignity and rights, free from poverty and in the best possible health. We may not always have simple answers, but we always have a clear attitude: For us, global solidarity is both a means and an end.

Our work in 2020 has also been massively challenged by the Corona pandemic. In this context, medico's long experience with global health issues has been very helpful in making demands heard for equal access to health care for all. This has been demonstrated, for example, by our call for the abolition of pharmaceutical patents on vital vaccines and medicines, which we drafted with international partners. In Germany, this has resulted in the #MakeThemSign campaign, supported by many civil society organizations, to enforce the release of patents. Our criticism, formulated for many years, that voluntary cooperation between politics and business is not „for the benefit of all“ has also proven fatally justified when it comes to the issue of global vaccine equity.

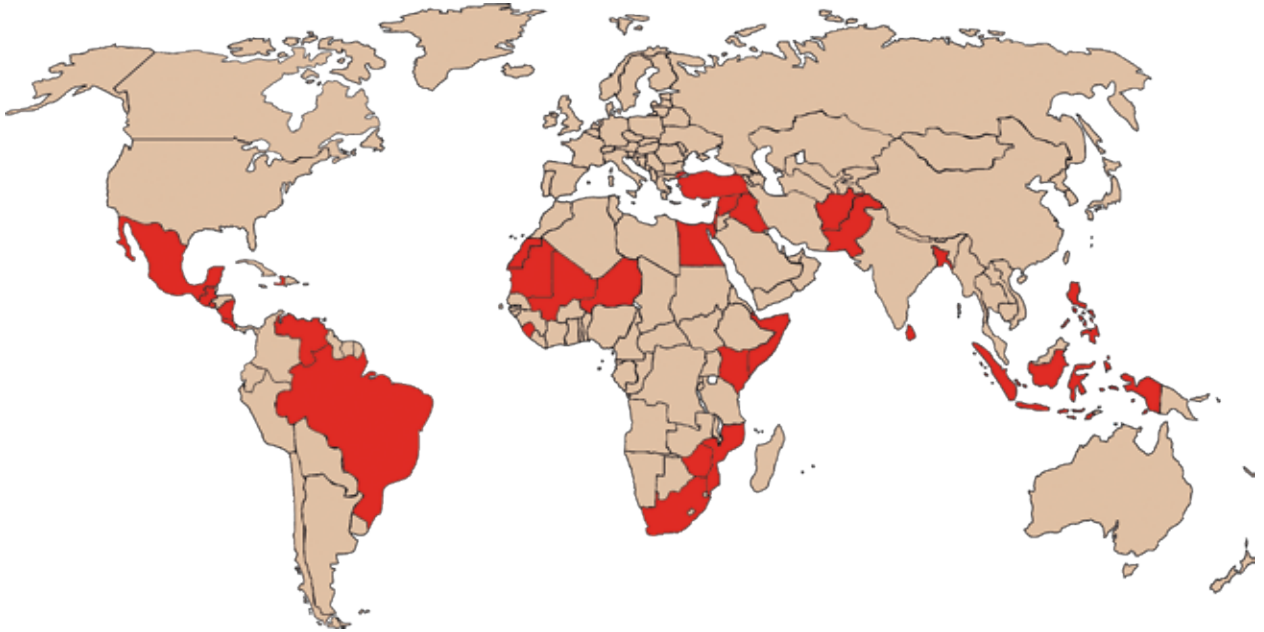
What is clear is that Covid-19 is not just a medical issue. The virus exposes economic, social and political inequalities while exacerbating them. In many places, the pandemic has also been used to legitimize massive restrictions on fundamental rights, and in numerous countries it has spurred authoritarian and repressive measures. In addition to political restrictions, many of our partner organizations have also been directly affected by the economic and social devastation resulting from the pandemic. All of this makes it even more urgent to provide solidarity support.

In total, we supported nearly 130 collaborations in more than 30 countries in 2020, more than ever before. As in previous years, the countries that stand out in terms of volume are Israel/Palestine, Lebanon and Somalia. Here, but also in many other countries, projects to contain the Covid-19 pandemic and manage its consequences have been launched, expanded or reallocated. The focus was on education and prevention as well as emergency aid in acute health crises, but also economic crises. For example, after millions of textile workers in Pakistan were forced onto the streets as a result of lockdowns in the importing countries like Germany our trade union partners reallocated funds to acute survival aid. Support for basic health services and psychosocial work was also increased. In addition, there was urgent support for health policy initiatives and networks working against authoritarian forms of infection control and for health equity.

This was also possible because we received significantly more donations than in the previous year, even though the pandemic also hit Germany. This expresses the conviction, which also guides our work, that global crises can best be countered with global solidarity – in the pandemic and beyond.

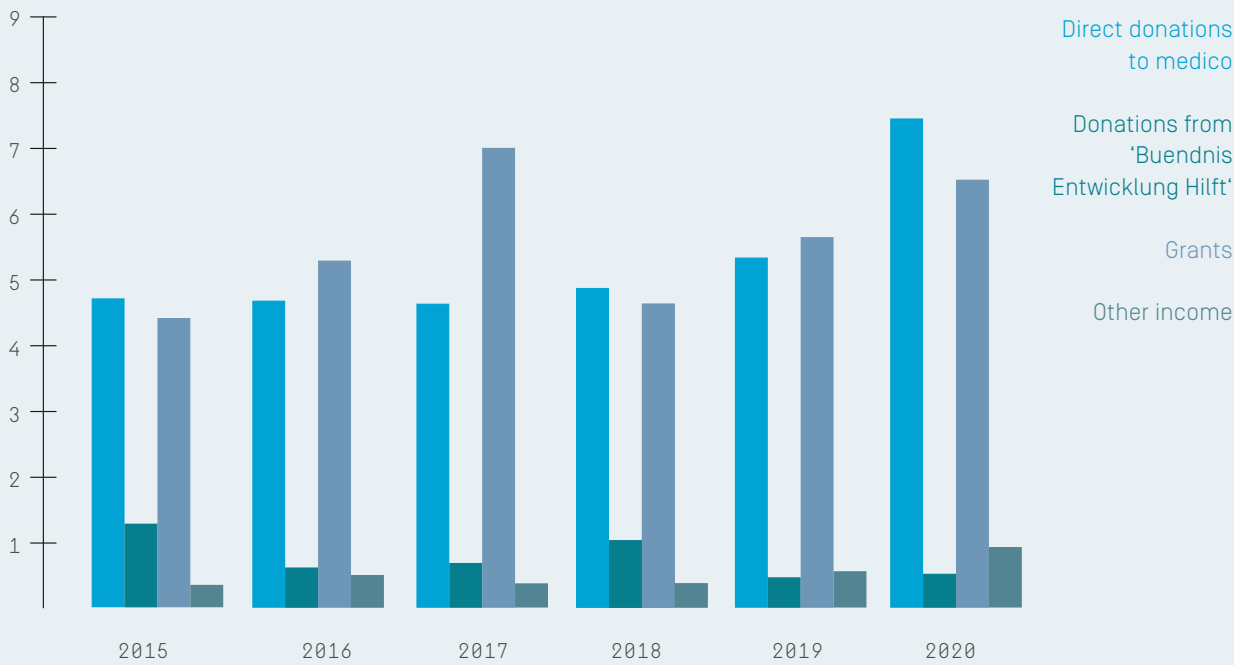

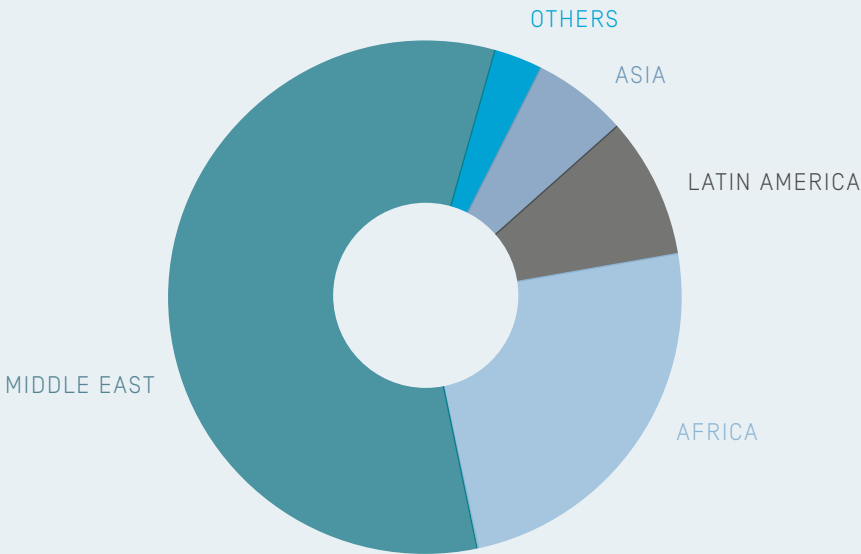
